 - Payment of inscription fee (500 euros)

ALMUNÉCAR INTERNATIONAL SCHOOL CONDITIONS

- 1. I agree to supply the matriculation fee and the following documentation to the school within 10 days of the date of this inscription, before my child starts at the school.
 - a) Copy of the birth certificate or passport of my child/children.
 - b) Copy of passport or DNI of mother and father.
 - c) Medical certificate confirming that he/she does not have any infectious diseases.
 - d) Vaccination card (T.B., polio, etc.).
 - e) Official certificate/report confirming prior studies.
 - f) Two passport photographs.
 - g) Latest school report
- 2. A place will be reserved once the following requirements are fulfilled: full payment of the school fees from the previous year up to the mentioned date, including exam payments, and payment of the registration fee. Students will only be accepted on to school trips/exchange visits if payment of school fees is up to date.

Instalments of fees must be paid by standing order or bank transfer to the school bank account, or by credit card in the school office. If the school fees are not paid by these dates, the School will charge 10% interest as a late payment interest established by law.

School fees are fixed and there is no reduction or refund in cases of absence, illness, withdrawal or dismissal.

If school fees are not paid in due time, the school reserves the right to exclude the student from classes. For any child who is accepted into school during the school year, fees will be proportionally calculated from the date of entry. The same will apply to the inscription fee, depending on the remaining school days.

- 4. I agree to notify the school of any changes of address, telephone number etc. immediately.
- 5. I agree to notify the school of any foreseen absences and to call the school before 10:00 on the first day of absence and send an official note (eg. medical certificate) justifying any absence to the school on my child's return.
- 6. I shall ensure that my child/children wear the correct uniform to school or formal school activities. I shall mark all items with a name label.
- 7. I agree that my child shall not wear excessive jewellery, any facial piercings and shall not come to school with any hair colour outside the natural spectrum or inappropriate or extreme haircut.
- 8. I agree to provide the necessary equipment for my children (i.e. pens, pencils, rulers etc.) not supplied by the school and to purchase the relevant course textbooks and reproduced materials as notified by A.I.S.in addition to the included textbooks.
- 9. I accept the right of A.I.S. to suspend or expel any pupil who fails to follow the agreed procedure and school rules
- 10. I understand that pupils cannot smoke, or bring alcohol or drugs onto school premises and that doing so would lead to immediate and permanent exclusion.
- 11. I agree to pay for any deliberate damage caused by my child/children to school property and accept legal liability for any physical injury (deliberately caused) to members of staff or other pupils.
- 12. I understand that pupils may not leave the school unaccompanied after school, without the written permission of parents/guardians. In such cases the school will not be responsible for their safety.
